pumper truck with the next three years. There will be a cost to the townships for this replacement, the
cost will be determined toward the end of 2017. Reviewed a recent report by Glen Castore and
discussed the need to bring in and train new firemen. Reviewed the latest NAFRS budget.

 - Brad Pfahning reviewed the recent amount received from Rice County for the Landfill \$144,920.
 - o Claims were reviewed; Gary Ebling made a motion to approve the February claims, Kathleen Doran-Norton seconded, all approved.

 - o Brad Pfahning reviewed bank statements and balances versus budget.

Planning & Zoning

- Staff Report
 - Reviewed the single permit received this month.
 - Discussed the need for the completed Certificate of Occupancy from Benny Svein prior to closing out the permit.
 - o Jim Braun has completed the SSTS report.
 - o Jim Braun is working with Seeds Farm regarding upcoming improvements.
 - A water sample was taken from a pond at SMC, the water will be tested and results reviewed when available.
 - o It was noted that the Bridgewater Planning and Zoning Commission will meet on the last Thursday of the month going forward.
 - o A discussion was held regarding the Keith Johnson junkyard

- Jim Braun noted that Mr. Johnson was way out of compliance regarding the current C.U.P.
- Jim Braun questioned if Mr. Johnson had closed the junkyard and if he was impounding cars; if so, a new C.U.P. would need to be applied for.
- This topic will be covered during the next Planning and Zoning meeting.
- A discussion was held regarding 13145 Faribault Ave and the house behind it. Both of these properties need to be declared unlivable as they are in need of excessive repairs. The Board of Supervisors gave approval to have Jim Braun contact Peter Teide to work on condemning these locations.

 - How could we determine if properties are taxed at 80% versus 100%
 - Properties in question will be sent to the Assessor and they will let us know what percent the properties are taxed at.
 - John Holden made a motion to have the tax assessment reviewed by Reese Associates before sending the numbers to Dundas, Gary Ebling seconded, all approved.
