Pole/Agricultural Building Permit Application Check List

Notice: Please review and follow the check list to avoid any delays in the permit process.

The following information must be included in the permit application for the permit to be considered.

1. **Completed Building Permit Application**
2. **Survey or Site Plan**
3. **Building Plans (three sets of full size plans or electronic set)**
4. **Erosion Control Plan**
5. **Truss Specs**
6. **Feedlot Permit (may be needed if housing animals)**
7. **Use of Building (Personal, Business, or Ag)**

General Information

Building Plans:

Elevation Drawings: exterior views of front, rear and sides of the finished building. **Floor**

Plans: post location and post spacing; window and door locations (safty glazing if required); interior walls; header sizes; stairs; and plumbing (including floor drain locations if any); mechanical equipment and mezzanine, if any.

Section Drawings: side cutaway view showing details of the footing, insulation (if any), floor, wall and roof construction. Provide roof truss specifications.

General Zoning: All zoning requirements must be met. Separate permits are required for plumbing, heating, fireplace installation, electrical work, and installation of a septic system.

Electrical wiring: All electrical must be inspected and approved by a state electrical inspector. Contact Minnesota Electrical Inspector Randy Edel at 507-334-3748 from 7:00am to 8:30am, Monday through Friday, to schedule an inspection or to answer your electrical questions.

Driveway Permits: Driveway permits may be required for access to state, county, or township roads.

Requirements for Agricultural building

****Agricultural Building:**

An Agricultural Building is a structure on an agricultural classed parcel at least ten (10) acres in size and used **exclusively** for storage of agricultural goods or equipment and/or used to house animals.

Note: The site plan shall show all existing structures, proposed structures, sewer systems, wells, and driveways. Include all distances from lot lines, roads, shorelines (if in the shoreland area) and the distance between buildings.

Property Owner Waiver

Minnesota State Contractor Licensing Requirements

The purpose of this form is to have property owner acknowledge responsibilities to the Minnesota State Building Code, to Zoning Ordinances, and to other applicable rules and regulations when they are acting as general contractor in building projects.

I understand that the State of Minnesota requires that all Residential Building Contractors, Remodelers, and Roofers, obtain a State License unless they qualify for a specific exemption from the licensing requirements. By signing this waiver, I attest to the fact that I am building or improving my property by myself. I claim to be exempt from the State License requirements because I am not in the business of building on speculation or for resale and this is the only residential structure that I have built or improved in the past 24 months.

I acknowledge that because I do not have a State License, I forfeit any mechanic's lien rights to which I may otherwise have been entitled under Minnesota State Statute 514.01.

I acknowledge that I may be hiring independent contractors to perform certain aspects of the construction or improvement of the property. Some of these contractors may be required to be licensed by the State of Minnesota. I understand that unlicensed residential contracting, remodeling, and/or roofing activity is a misdemeanor under Minnesota State Statute 326B.082, subdivision 16, and that I forfeit my rights to reimbursement from the Contractor's Recovery Fund in the event that any contractors that I hire are unlicensed.

I also acknowledge that as the contractor on this project, I am solely and personally responsible for any violations of the State Building Code and/or Jurisdictional Ordinance in connection with the work performed on the property.

Minnesota State Contractor License Law

Notice to Homeowners: Be Sure Your Contractor is Licensed

Know your Rights.

The State of Minnesota recently adopted a statewide “*Contractor and Remodeler License Law.*” This law is designed to protect the consumer by requiring that contractors be licensed with the State. Contractors must apply to the State, post a bond, and show proof of insurance and competency. The law gives homeowners reasonable assurance that they are dealing with a reputable, professional contractor, and a place they can call to get general contractor information.

Getting Information on a Contractor

Contractors, with a few exceptions, who contract with a homeowner to perform home construction, remodeling, or repair, must be licensed with the Minnesota Department of Commerce. Homeowners can call the Commerce Department Licensing Division at 1-800-657-3602, 651-296-2488 or visit the web site @ www.commerce.state.mn.us to obtain information on a specific contractor. Contractors must display their license number on their advertising and they must make it available to consumers. Building permits cannot be granted to contractors who are not properly licensed by the state.

Exceptions to Being Licensed

State law exempts contractors who have gross annual receipts from the construction business of less than \$15,000. Also, exempt are specialty contractors who perform only one specialty skill.

Homeowners Rights if a Contractor is Not Licensed

If your contractor is required to be licensed by the State of Minnesota and you find that he/she is not, you may still have recourse under the law. Generally, the law provides that a contractor who is working in violation of the Minnesota State License Law has no lien rights and may not be able to enforce a contract signed with a homeowner. If you find yourself in this situation, you should consult with an attorney to get sound legal advice. You should never knowingly hire someone who is deliberately violating the State License Law.

Working on Your Own Home

You can obtain permits to do work on your own home. The License Law was written to insure a reasonable degree of protection for you as the consumer of construction services, not to discourage homeowners from doing work on their own property. For your safety, building permits are required for most construction projects.
